TCF will not be liable for any detention charges for containers notified as ready for collection after this time.

With regard to **deliveries**, there will be limited capacity on Monday 24 December and Monday 31 December, so normal operations will recommence on Tuesday 2 January. TCF will ensure that any container requests for special collection over the Christmas period will be delivered out as quickly as possible.
