\*All containers collected from Thursday 1 April to 5 April that cannot be delivered due to Clients premises being closed will incur Staging Fee, Back to Yard and Storage Fees

\*\*Additional fee for collection of containers and LCL cargo during this period from bonded facilities and moved to nonbonded facilities will apply. If cargo cannot be transferred additional higher storage charges will apply

Please note that due to the extended period of closure for Easter, subject to vessel availability advised by Australia-wide Ports, only limited deliveries will be available on Thursday 1 April and we will endeavour to collect all empty containers as notified.

Regarding **deliveries**, we will re commence normal operations on Tuesday 6<sup>th</sup> April.

Note that due to continued and ongoing Empty Container Park capacity issues in both Sydney and Melbourne, as well as consistent re-directions of containers occurring, container de-hires are requiring 72 business hours from time of notification for collection. Detention charges incurred during this time will of course be passed on at cost.
